Main duties and responsibilities:

1. Administer, plan and act as primary facilitator for IFCA Torquay course

2. Develop and administer first 6 month induction program for new officers in all IFCA's
3. Introduce new developments and processes in field of enforcement into IFCA's in a standardised way to ensure existing officer continuous professional development
4. Provide IFCA central contact point for organizing training with other organisations
5. Develop and administer additional IFCA course (3-5 days) to deliver advanced inspection and enforcement skills development and refresher training
6. Organise external training providers and deliver internal specific training to individual IFCA's on an as requested basis
7. Act as Internal Quality Assessor on accreditation programme
8. Sit on relevant national groups to ensure IFCA involvement and assistance to partners in training development
9. Undertake any other future training deliveries as determined by the Association of IFCA's
